Appointment: The Psychiatrist is a Contractor. This professional possesses experience, knowledge, and skills in the provision of the services.

Responsibilities and Duties:

- The contractor will provide psychiatric assessment and evaluation services for CLARE | MATRIX within 24 hours of admission in electronic form based on the agreed schedule
- Provide a minimum of weekly hours TBD by Consultant Agreement.
- Provide minimum hours of direct patient visits, as needed to ensure smooth mental health and co-occurring treatment services
- Provide individual Medication Consultation and follow-up treatment sessions as appropriate for the patient in treatment, including responding to emergency calls from treatment team within 60 minutes
- Documentation may include writing of prescriptions and calling prescriptions into preferred pharmacies
- Ongoing monitoring and management of medication and medically assisted treatments
- Order, review and signoff on all orders, Urine Analysis Orders, and documentation in relation to upholding DHCS, CLIA and CCL licenses and CARF accreditation
- Coordination of client/patient care needs with other treatment team members
- Review and sign off on treatment plans as required
- Complete disability forms as necessary

- Conduct UR peer reviews when necessary
- In alignment with the standard of care, remain available to answer calls regarding patient emergencies 24/7 for assigned clients. Responding to phone calls from clinical staff concerning clinical changes in clients that require a psychiatrist's guidance
- Clear, concise, timely and legible documentation of assessment, evaluations and follow-up evaluations and services
- Complete billing sheets daily and submit to CLARE | MATRIX billing team
- Other mutually agreed upon duties as required as the Physician of record
- Be X-waivered or willing to take training to become X-Waivered

Knowledge, Experience & Skills:

The ideal candidate will have a strong understanding of the client care landscape. The following are strongly desired:

- Licensed Psychiatrist , Active CA license
- X-waivered or willing to take training to become x-waivered
